

# SOYBEAN HERBICIDE RECOMMENDATIONS NON-DICAMBA

## START CLEAN

use appropriate burndown herbicide at labeled rate or tillage

## PRE/AT PLANTING APPLICATION

within five days of planting but prior to soybean emergence

**CHOOSE** a premix or a tank mix with at least **three active ingredients**<sup>1</sup>  
at full labeled use rates from Group 2<sup>2</sup>, 3, 5<sup>2</sup>, 14 or 15<sup>3</sup>

When choosing active ingredients from 2, 3, or 5, then a group 14 or 15 has to be included

*Recommend adding a Group 2 active ingredient in places where there are dense populations of large-seeded broadleaf weeds*

## POST-EMERGENCE APPLICATION<sup>4</sup>

within 4 weeks of planting and when weeds are less than 3-4 inches tall<sup>5</sup>  
(recommend 20-30 days after planting)
