

WEED MANAGEMENT RECOMMENDATIONS

Recommendation for Cotton in Alabama, Georgia, South Carolina, North Carolina, Virginia

START CLEAN

use appropriate burndown herbicide at labeled rate or tillage

Considering using a cover crop as a beneficial tool for managing pigweed.

Pre-Emergence

At planting (within 2 days of planting)

Post-Emergence Application

Apply 10-17 days after planting, on less than 3 inch weeds
